THE LOAN AND ACCRUED INTEREST ARE FORGIVABLE AS LONG AS THE BORROWER USES THE LOAN PROCEEDS AS DESCRIBED IN THE CARES ACT.

LEGAL ASSISTANCE CAN FACILITATE IMMIGRANTS' TRANSITION TO VALID LEGAL STATUS, WHICH ENABLES THEM TO OBTAIN LAWFUL EMPLOYMENT, RECEIVE FINANCIAL AID AND IN-STATE TUITION TO ATTEND SCHOOL (THUS IMPROVING THEIR EARNING POTENTIAL), ACCESS HEALTH INSURANCE AND, IF NECESSARY, OBTAIN TEMPORARY BENEFITS SUCH AS FOOD AND INCOME SUPPORTS. PREVENTING DETENTION AND DEPORTATION KEEPS IMMIGRANT CHILDREN FROM BEING FUNNELED INTO FOSTER CARE OR SUFFERING THE EDUCATIONAL AND HEALTH COMPLICATIONS OF FAMILY SEPARATION.
