IMMIGRANTS AND THEIR CHILDREN MAKE UP NEARLY HALF OF THOSE LIVING IN POVERTY IN NEW YORK CITY. MORE THAN 800,000 PEOPLE AND NONCITIZENS EXPERIENCE POVERTY AT MUCH HIGHER RATES THAN THE CITY OVERALL. DETENTION AND DEPORTATION PRACTICES HAVE EXACERBATED THESE CHALLENGES. BETWEEN 2005 AND 2010, THE PARENTS OF OVER 7,000 U.S. CITIZEN CHILDREN IN NEW YORK CITY WERE DEPORTED AND OVER 10,000 WERE DETAINED WITHOUT BOND, RESULTING IN SIGNIFICANT HARDSHIP AND EMOTIONAL TRAUMA.
