#### **Role Description**

This will include developing reports and analytics for both internal and external purposes and assist in strategic decision making for program development. The Data and Impact Analytics Manager will also oversee the organization's case management system(s) assuring the quality, production, and efficiency of data and system processes. The Data and Impact Analytics Manager will be part of the Program Team reporting to the Deputy Director but will play a key role for the organization across functions and interact closely with Operations and Communications.

- Train, troubleshoot and serve as point of contact for fellows and staff on data and tech systems

- Develop new techniques, models and plans within area of expertise and develop user guides and processes for data management.
- Evaluate complex situations using multiple sources of information filters, validate and interpret dynamic material.
- Apply developed project management techniques.
- Define the technical implementation of the software architecture.

- Responsible for overseeing software design and/or upgrade and development including database transitions.
